I am submitting for your consideration the re-appointment of Ms. Genet M. Barthwell to the Wayne County Jury Commission.


Under Public Act 454 of 2000, enacted January 9, 2001, (MCL 600.1301(2)) upon recommendation of the Wayne County Circuit Court Judges the Wayne County Executive is empowered to appoint no more than seven members to the Jury Commission. Concurrence of the Wayne County Commission is required. Not more than four Jury Commission members shall represent the same political party.

Pursuant to this legislation, the Wayne County Circuit Judges have recommended the re-appointment of Genet M. Barthwell to a six-year term as a member of the Wayne County Jury Commission. A letter from Chief Judge Virgil C. Smith is enclosed. The term shall commence upon County Commission approval and expire June 16, 2016.

Ms. Barthwell's party affiliation is Republican. She is a resident of Detroit and her resume is attached.
